Programme of your Institution under Baba Saheb Ambedkar Education University (Erstwhile WBUTTEPA) for the academic year 2023-2024 subject to the fulfillment of the following terms and conditions:

1. The college shall be guided by the NCTE Regulations 2014 in respect of appointment of teaching and non-teaching staff, purchase of books, audio-visual material and automation of the library.
2. The college will continue to organize and equip the laboratories as per stipulation of NCTE. Other infrastructure are to be maintained as per NCTE norms.
